

California Voters First Act Redistricting Commissioners

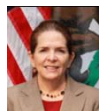
The 14-member Citizens Redistricting Commission is charged with defining the geographic boundaries for 53 congressional, 80 State Assembly, 40 State Senate, and 4 State Board of Equalization districts by Aug. 15, 2011.
